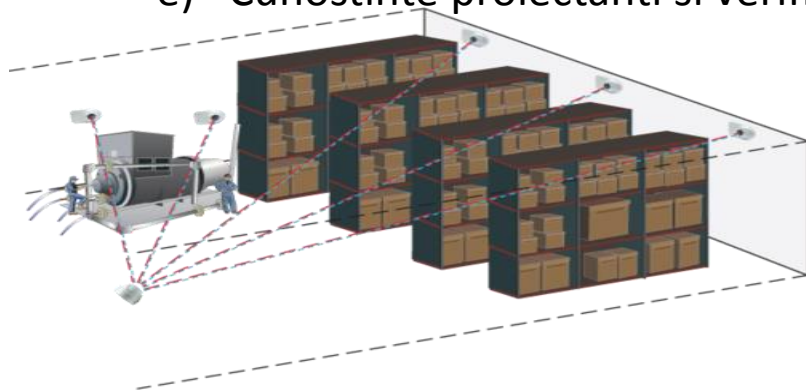


OPTICAL SMOKE IMAGINE DETECTION APLICATII
